An HNHC Staff member will be on-call during this time, but will only be responding to telephone calls that are considered a maintenance emergency in nature - loss of heat, loss of hydro, water leaks or damage, smoke detector malfunction, fire, or death.

Your consideration in waiting until Monday, January 4, 2021 for other non-emergency maintenance requirements is greatly appreciated.

COMMON ROOMS

The Housing Corporation took the unusual step of closing common rooms and common washrooms in the Spring of 2020 as a result of the COVID-19 pandemic and subsequent Municipal and Provincial Emergency Orders. The closure was in response to Public Health guidelines that prohibited gatherings in enclosed public spaces and due to the Housing Corporations' challenges with ensuring these spaces are disinfected and sanitized after each use.

At this time the common rooms and washrooms will remain closed to all tenants. We will only reopen these areas when the Province and the Municipality have removed COVID-19 restrictions and we are confident that we can offer this space safely to tenants.

We encourage all tenants to continue to practice social distancing, frequent hand washing, use of hand sanitizer and to wear a mask when outside of their apartment, including in the common areas of the building.

We would like to thank you for looking after the building and each other during these uncertain times.

UNIT INSPECTIONS

Please be advised that unit inspections have been paused until it is safe to resume.

Due to the coronavirus, housing staff will be limiting their interactions at the buildings to assist with keeping everyone safe.

We all need to do our part to help with controlling the spread of this virus so we are following the guidelines strictly.

We kindly ask that tenants call our office to report maintenance emergencies like plumbing and electrical issues as well as life safety concerns such as smoke detectors beeping and loose railings. If you are unsure about a repair, please call our office and housing staff can determine how to proceed.

Our hope is that things will return to some sense of normalcy and inspections and many other things can proceed later in 2021.

BLIZZARD CONDITIONS

Please be advised that during a blizzard snow will be removed from the building roadway and the building entry doors as often as is required so that emergency personnel can safely attend to your building in the event of an emergency.

Normal snow clearing operations, as noted above, will start after the blizzard is over. Staff will also attend on-site after the blizzard is over to determine if the snowfall has been so great as to warrant plowing the entire parking lot, including all parking spaces. If that is the case you will be notified in writing and asked to move your car out of the parking lot.

WINTER HEATING CHECKLIST

Run through this checklist to make sure you are staying warm this winter!

- Make sure all furniture/belongings are pulled away from the heaters in your home.
- ☑ Ensure all doors and windows are shut tight.
- Report any air leaks or drafts to the property management team.
- ✓ During the day, open your blinds to let the sun in.

EMERGENCY REPAIRS AFTER THE OFFICE IS CLOSED

The Housing Corporation considers the following to be After-Hours Emergencies: no heat, no hydro, burst pipe that is gushing water, sewer backup, fire or death. Needless to say, for fire or death, please call 911 immediately!

For maintenance emergencies, please call our answering service to report an after-hours emergency at:

The on-call duty manager will call a contractor and ask them to attend as soon as possible.

Please note that sometimes a staff person will advise you that your call is not considered an emergency and that we will issue the work order on the next business day. For example, if the pipes have let go under your kitchen sink, we will ask that you not use the sink until the next business day. As another example, if you have hydro to half your house, and it's after 11:00 p.m., we may ask you to wait until the morning, simply because contractors may not be available at this time.
